BREAKTHROUGH-PHARMACEUTICAL CONTRACTS

A few hours ago, the TSJIB(superior Court of Justice of Balearic Islands) just informed us of the following court order.

After the request made by Liberum and 549 citizens, the TSJIB has agreed on July 28, 2022, in the DDFF 14-2022 procedure, to REQUEST by OFFICE, so that within 10 days, the MINISTRY OF HEALTH provides the documentation requested and declared as pertinent evidence by the TSJIB.

- 1.- THE CONTRACTS SIGNED AND SUBSCRIBED BY THE GOVERNMENT OF SPAIN WITH THE PHARMACEUTICAL COMPANIES PFIZER, ASTRA ZENECA, MODERNA AND JANSEN and/or the Commission of the European Union, in relation to the Covid-19 vaccine, expressly mentioning that they must provide A COPY OF THE ORIGINAL CONTRACTS, where the price of the doses, deliveries, possible compensation for drug failures, as well as all the clauses and stipulations of the same, are stated.
- 2.- That the Interterritorial Health Council provide the VACCINATION EFFECTIVENESS STUDIES THAT, WHEN THE INDEX CASE AND ITS CONTACTS ARE VACCINATED, THERE ARE MORE INFECTIONS DUE TO A GREATER RELAXATION OF MEASURES THAN IF THE CONTACTS referred to in the Presentation are NOT VACCINATED referring to the Alerts from the Interterritorial Health Council dated November 23, 2021.
- 3.- That the TOTAL NUMBER OF ADVERSE EFFECTS OF COVID-19 VACCINES IN THE BALEARIC ISLANDS be certified.
- 4.- That the TOTAL NUMBER OF PEOPLE DECEASED DUE TO ADVERSE EFFECTS OF COVID-19 VACCINES IN THE BALEARIC ISLANDS be certified.

From the LIBERUM LEGAL TEAM, we highly value the UNPRECEDENTED JUDICIAL PROGRESS. Finally, the public will be able to discover all those clauses, spuriously stolen. We have witnessed a wild violation of fundamental rights, under the cover of a NON-EXISTENT emergency and under the umbrella of "CONTRACTS-LAW or SECRET MILITARY CONTRACTS", which have circumvented our constitutional order and legal order of values and Human Rights.

The contracts signed with the PHARMACEUTICAL HOUSES must be public and FINALLY WILL BE. It is incomprehensible and legally unacceptable that, in a matter as delicate as the health of the population in general, they were hidden precisely from those millions of people who are the recipients of the clauses of these, de facto breaking the INFORMED CONSENT necessary to have all the data about the treatment from which they were to be inoculated.
